ELECTION DAY NOTICE:

ARRANGEMENTS IN RESPECT OF THE NATIONAL DAY 29 MAY 2024

As a result of the National Election Day arranged for Wednesday, 29 May 2024, all court proceedings set down for that day in Gauteng Division, Pretoria shall be reallocated as follows;

1. Civil trials

- 1.1. Civil trial matters allocated for the 29 May 2024 shall be heard on the 22 July 2024.
- 1.2. Civil trial matters allocated for the 30 May 2024 shall be heard on the 23 July 2024.
- 1.3. The Plaintiff must serve a new notice of set down, together with a Practice note on the Defendants and thereafter upload on the Caseline System. If no notice of set down for abovementioned dates is timeously served on the Defendants, The Registrar shall automatically remove the matter from the roll and date forfeited.
- 1.4. Civil trials allocated for 31 May 2024 will be dealt with at roll call on 31 May 2024.

- 1.5. No RAF Default Judgments matters have been set down on the roll of 29 May 2024.
- 1.6. No RAF Settlement matters, have been set down for hearing on 29 and 30 May 2024.

2. Appeals

- 2.1. Civil and Criminal Appeals matters set down hearing on the 29 May 2024 are all removed and postponed to later dates to be confirmed by the Appeals Registrar to the relevant Parties.

3. Motion court

- 3.1. The RAF Trial Interlocutory Court Applications and Unopposed motions set down for the 29 May 2024 are removed from the roll.
- 3.2. No Special Motion Matters (Third Court Motions) have been set down for hearing on 29 May 2024.
- 3.3. The Judge hearing Opposed Motion Court Applications will not allocate any matter for hearing on the 29 May 2024.

4. Urgent applications

Urgent Applications from Urgent Court Roll from 24 – 31 May 2024 will be dealt / allocated accordingly by the Urgent Court Senior Judge.
